## MSDS Exemption

Thank you for your recent MSDS request concerning: **North Buffered Eyelet (Buffered Sterile Isotonic Saline Solution which is non-toxic to the skin, along with being clear, colorless, odorless and non-hazardous.) Contents include: Sodium Chloride USP, Sodium Phosphate, Monobasic, Monohydrate USP, Sodium Phosphate, Dibasic Heptahydrate, USP, Edetate Disodium Dihydrate, USP, Benzalkonium Chloride 50% Soln. NF and Deionized water.**

This product is a consumer product which is regulated under the Federal Food, Drug and Cosmetic Act by the Food & Drug Administration. OSHA has provided several exemptions for these type of products under 29 CFR 1910.1200; the following is a brief summary.

- 29 CFR 1910.1200 (b)(6)(v) Exempts foods, drugs or cosmetics in retail establishments (packaged for sale to consumers).
- 29 CFR 1910.1200 (b)(6)(vi) Exempts foods, drugs or cosmetics when they are intended for personal consumption by employees while in the workplace.
- 29 CFR 1910.1200 (b)(6)(vii) Exempts consumer products when they are used in the workplace in a similar manner to a consumer's use.
- 29 CFR 1910.1200 (b)(6)(viii) Exempts drugs as defined by the Federal Food, Drug and Cosmetic Act when they are in solid final form (tablets or pills)
